

# **2013 City Lites Car Raffle Official Rules**

The 2013 City Lites Car Raffle Raffle (“Raffle”) begins on April 4, 2013 at approximately noon, and ends on June 1, 2013 at approximately 3:30 P.M. (“Raffle Period”). The Raffle is sponsored by City Lites Network Inc., 520 North La Brea Ave, Ste. 109 Inglewood, CA 90302. The Official Rules of the Raffle are set forth herein. By entering the Raffle, Entrants agree to be fully and unconditionally bound by these Official Rules, waive any right to claim ambiguity in the Raffle or the Official rules and the further agree to be bound by the Sponsor’s decisions and interpretation of the Official Rules.

In the event that any provision of these Official Rules is deemed unenforceable, the remaining provisions remain enforceable.

Void where prohibited by Law. Entrants must be 18 years or older.

## **1. Eligibility:**

The Raffle is open to all persons age 18 and over whom are legal U.S. residents physically residing in the United States and DC. The Board of Directors of the City Lites is not eligible.

## **2. How to Enter:**

Raffle tickets (“Tickets”) cost five dollars (\$5) each. Tickets may be purchased during the Raffle Period.

- a. In Person: Purchase Tickets directly from a member or affiliate of City Lites. All in person Tickets must be purchased by June 1, 2013, at the City Lites office (until May 31, 2013 5PM) or at Earvin Magic Park (June 1, 2013 only). In person Tickets payments by check, money order, or cash. All checks and money order should be made out to “City Lites.”

b.

Subject to availability, Entrants may purchase as many Tickets as they wish. Tickets are personal and can only be in the name of (1) individual Entrant. Entrants may not sell, donate or otherwise transfer their Ticket (S) to anyone. Prize(s) will not be issue to anyone other than the one (1) Entrant whose name is on the Entry Form.

Sponsor reserves the right to disqualify false entries or entries suspected of being false, and any illegible, defective, incomplete or physically altered Entry Forms and entries that do not include valid or complete payment. Sponsor is not responsible for printing errors in and Raffle –related material, or for lost, late misdirected or non-delivered mail or corrupt or any other failure to receive orders or deliver receipts prior to the drawing deadlines. All entries become the property of Sponsor and will not be returned.

### **3. Drawing :**

One (1) random drawing will be conducted by a representative of Sponsor as described below. Entrants need to be present to win. Car Raffle Drawing will be held on June 1, 2013. The drawing will be made at random.

### **4. Notification:**

The Selected Entrant must will be asked to sign an affidavit of eligibility/ liability/ publicity release (“Release”) The Selected Entrant must provide all information requested to be eligible to win, including proof of age, proof of identity, showing that the person claiming the prize is the same Entrant named on the winning Ticket and the winning Ticket stub.

Unless restricted by law, the Selected Entrant will be required to complete and return the Release within fourteen (14) days of prize notification. This Release should be returned by mail to 520 North LaBrea Ave., Ste. 109 Inglewood, CA 90302. The prize may be forfeited if the Selected Entrant (i) cannot be reached; (ii) fails to obtain all signatures on the Release and to return the documents in a timely manner as required pursuant to these Official Rules; or (iii) cannot accept or receive the prize for any reason. The Selected Entrant grants permission for the use of his or her name, photographs, or likenesses for advertising and promotion for this and similar promotions without compensations, unless prohibited by law.

### **5. Prize:**

Winner is subject to relevant federal, state and local taxes. Other expenses, including automobile license, taxes, and other transfer fees in connection with the Prize are the sole responsibility of the Selected Entrant.

No substitution, transfer, or cash redemption of prize, provided.

### **6. Proceeds:**

Proceeds from the Raffle will benefit City Lites and its ongoing programming in Los Angeles, CA

### **7. General Conditions:**

The Raffle is subject to these Official Rules. Entrant acknowledges and understands that the Official Rules are the only terms governing the duties and obligations of Sponsor and Entrant in regards to the raffle. This Official Rules Shall not be changed by any oral statement made by any person acting on behalf of the Sponsor. By Participating, Entrants agree: and (i) to be bound by these complete Official Rules and the decisions of Sponsor with shall be final and binding; and (ii) to waive any right to claim ambiguity in the Raffle or these Official Rules, except where prohibited by law. By accepting the Grand Prize, Selected Entrant agrees to release Sponsor, its officers, directors, representatives and agents, and any person or entity associated with the production, judging, or administration of the Raffle ( collectively the “Releases”) from and

against any claims, damages, disability, attorneys' fees, and costs of litigation and settlement, as well as any liability due to any injuries, damages or losses to any person ( including death) or property of any kind resulting in whole or in part, directly or indirectly, from redemption, acceptance, possession, ownership, misuse or use of any prize or participations in any Raffle-related activity or participation in this Raffle. Except where prohibited by law, the Selected Entrant's name, photograph, likeness, statements, biographical information, voice, and city and states address for promotional or advertising purpose in connection with the Raffle on a national basis, and in all forms of media, now or hereafter known, in perpetuity, without review, permission or further compensation. Taxes, if any, are the sole responsibility of Selected Entrant will be issued IRS Forms W2- G and W-9 for the value of the Prize. Each ticket purchaser is advised to consult his or her own tax advisor (s) with respect to the tax entrant it finds to be tampering with the entry process or the operation of the Raffle or violating the Official Rules, and reserves the right to cancel the Raffle should it suspect fraud or reasons out of the control of Sponsor. Disputes regarding these Official Rules and/ or this Raffle will be governed by the internal laws of the State of California.

A Raffle Entrant's sole and exclusive remedy for any claim against Sponsor arising out of the sale of raffle tickets or the conduct of the Raffle shall be limited to the return of the purchase price paid for his or her raffle ticket (s). In no event shall Sponsors, its directors, officers, employees, agents or representatives be liable to any party for any loss or injury to earnings, profits or goodwill, or for any incidental, special, punitive or consequential damages of any person or entity whether arising in contract, tort or otherwise, even if advised of the possibility of such damages.

CAUTION: ANY ATTEMPT TO DELIBERATELY DAMAGE OR UNDERMINE THE LEGITIMATE OPERATION OF THE RAFFLE MAY BE IN VIOLATION OF CRIMINAL AND CIVIL LAWS AND WILL RESULT IN DISQUALIFICATION FROM PARTICIPATION IN THE RAFFLE. SHOULD SUCH AN ATTEMPT BE MADE, SPONSORS RESERVE THE RIGHT TO SEEK REMEDIES AND DAMAGES (INCLUDING ATTORNEY FEES) FULLY OF THE LAW, INCLUDING CRIMINAL PROSECUTION.

#### **8. Privacy:**

All personal information collected by Sponsor will be used for administration of the Raffle. The Sponsor will not share, sell or otherwise distribute personal information collected except as stated above.

#### **9. Registration with State Of California:**

By letter from the Attorney General's office, City Lites has registered with the Department of Justice and is authorized to conduct raffles in California pursuant to the provisions of Penal Code section 320.5 for the raffle periods, beginning April 4, 2013 ending June 1, 2013.
